ARREED FRANZ BARABASZ VITAE ABSTRACT

Arreed Franz Barabasz, EdD, PhD, ABPP, at the age of 23, completed his first doctoral degree in Counseling Psychology at State University of New York at Albany. His PhD in Clinical and Human Experimental Psychology is from the University of Canterbury, New Zealand where he conducted the first studies of EEG and Hypnosis in Antarctica. His post-doctoral Clinical Fellowship was at Harvard Medical School & Massachusetts General Hospital. Arreed is a Full Professor and Director of the Laboratory of Hypnosis Research at Washington State University. He was Associate Professor of Psychology, Harvard University Medical School prior to his current position. Dr. Barabasz is the Editor of the *International Journal of Clinical and Experimental Hypnosis* (*IJCEH*)(2002-2018),the highest citation index ranked journal in the field. He is a licensed psychologist and Diplomat of the American Board of Professional Psychology (ABPP) - the highest distinction in professional psychology.

Arreed holds Fellow status for "Outstanding and unusual contributions to the science and practice of psychology," from the American Psychological Association (APA), the American Psychological Society, and the Society for Clinical and Experimental Hypnosis (SCEH). By appointment of the Governor, Dr. Barabasz served on the State Examining Board of Psychology1993-1998 in Washington State. He is Past-President of the Society for Clinical and Experimental Hypnosis (SCEH) (1999-2001) and Past-President of the American Psychological Association (APA) Society of Psychological Hypnosis (D30) twice (2002-2003 & 2013-2014).

Arreed has published over 125 refereed research papers and received numerous national awards for his achievements in research, theory and practice. Examples include: four-time winner of the Henry Guze Award from SCEH "for best research paper published in the previous year," "best theoretical paper" from both SCEH and APA, D30 and Distinguished Contributions to Science from APA. Four of his six books are published by Routledge/Taylor & Francis including *Hypnotherapeutic Techniques*, 2E, (2005), co-authored by John G. Watkins, winner of the 2005 SCEH Award for the "Best Book on Hypnosis." Arreed's *Advanced Hypnotherapy: Psychodynamic Techniques* textbook, also with John G. Watkins, won the 2010 Roy M. Dorcus Award for the "best clinical contribution" from SCEH.

He received the "Best Published Research Paper" Award from the American Psychological Association D30 in 2014, and the "Distinguished Contributions to Professional Hypnosis" award in 2015. Also in 2015, Dr. Barabasz won the coveted *Morton Prince Award* "In recognition of distinguished contributions to the development of hypnosis in the science and profession of psychology" from the American Board of Psychological Hypnosis.

Dr. Barabasz provides invited addresses and workshops on hypnosis and PTSD worldwide. He serves nationally as an expert witness for legal cases involving hypnosis.
