

# Fulbright Specialist Program



The Fulbright Specialist Program (FSP) promotes linkages between U.S. academics and professionals and their counterparts at overseas universities or institutions with education focused programming. The program is designed to award grants to qualified U.S. faculty and professionals, in select disciplines, to engage in short-term collaborative 2 to 6 week projects at higher education institutions in over 100 countries worldwide.

**Program Activities** - Focus is on the needs of higher education institutions and not personal research. Eligible activities include lecturing, training in pedagogy, participation in special conferences or workshops, collaboration on curriculum planning and institutional or faculty development.

**Becoming a Fulbright Specialist** - Applications are accepted on a rolling basis. They are evaluated by discipline peer review committees and if recommended are forwarded to the J. William Fulbright Foreign Scholarship Board (FSB). Approved candidates are placed on the Specialist roster for five years. Project must be submitted by the host institution to the Fulbright entity in the country. Host institutions are allowed to request a specific candidate in their project proposal. Specialists may assist their prospective host institution in developing the proposal.

## Eligible Disciplines -

**Humanities:** American (U.S.) Studies, Applied Linguists/TEFL, Law

**Social Sciences:** Anthropology, Archaeology, Business Administration, Communications and Journalism, Economics, Education, Library Science, Peace and Conflict Resolution Studies, Political Science, Public Administration, Public/Global Health, Social Work, Sociology and Urban Planning

**Natural Sciences:** Agriculture, Biology Education, Chemistry Education, Computer Science and Information Technology, Engineering Education, Environmental Science, Math Education, Physics Education

**Program Benefits** - The enhanced global perspective that Fulbright Specialists gain from their experience contributes to their professional development. Fulbright Specialist grants also lay the foundation for development of institutional linkages.

**Requirements** - Applicants must be U.S. citizens and have a Ph.D. or equivalent terminal/professional degree (or recognized professional standing and accomplishments) plus at least five years of university teaching experience or professional experience.
