ROAR Research: Monitoring Access to the ROAR Student Population

Background: The ROAR student population at Washington State University (WSU), like any other student population at WSU, is a potential source of information for research to inform educational systems and policies to aid the improvement of these systems and promote student success, performance, and achievement, broadly defined. Two main issues need to be clear when accessing the ROAR student population for research.

The first issue involves the two components of institutional vulnerability and conflict of interests, as defined in the Institutional Review Board member handbook (Amdur & Bankert, 2007). The concern is that the participation in research by this population may not be truly voluntary. It is assumed that any research protocol submitted with the aim to access the ROAR population will clearly document how this is handled, and will be vetted by the WSU IRB board, as such issues are with all research protocols. No additional oversight seems to be needed beyond what is required in the IRB guidelines.

The second issue involves the number and magnitude of the research protocols active at a given time with the ROAR population. There is no strict oversight by the IRB for this issue. Thus, it is proposed that the ROAR leadership team (RLT) track the (a) number of research protocols recruiting ROAR students, and (b) extent of involvement of ROAR students required by each protocol. The goal of this tracking is to ensure that the student population is not being asked to be involved in too many studies or too many studies that require major time commitments. The students' involvement in research should not be disruptive to the students' progress in the program.

Tracking Implementation: To implement this tracking, a person with a proposed study would (a) complete the *Research Study Access (RSA)* form found on the ROAR website, (b) submit this to the RLT through the director, and (c) meet with the RLT if requested. The RLT would log these requests in a RLT maintained database, review the RSA from, and see if there is consensus by the RLT that the proposed study fits within the scope of the ROAR program, given other research occurring at that time. The review process should not take more than 21 days.

If the RLT judges the number and magnitude to be too great with an additional proposed project, as to jeopardize the students' program progress, the RLT will ask the researcher with the new proposed project to wait to recruit students until another current study has finished data collection. This monitoring will require any researcher, associated with the ROAR program or not, seeking to recruit ROAR students to submit their approved IRB application to the RLT prior to beginning any aspect of the study, including participant recruitment activities. The monitoring of research activities should be noted in the ROAR policies and procedures and noted on program information where appropriate (e.g., student and parent information, website). This will help to ensure awareness of this monitoring.

Goal of Research Monitoring: This active monitoring should allow researchers to have fair and equal access to the ROAR student population, while maintaining a reasonable level of student time spent in such research activities. This proposed monitoring also honors the student's independence to decide what they wish to participate in, and not treating this population differently than required by IRB standards or standard practice typically found in school districts. This is important because we would not want additional policies to do more harm than good to this student population (Amdur & Bankert, 2007).
